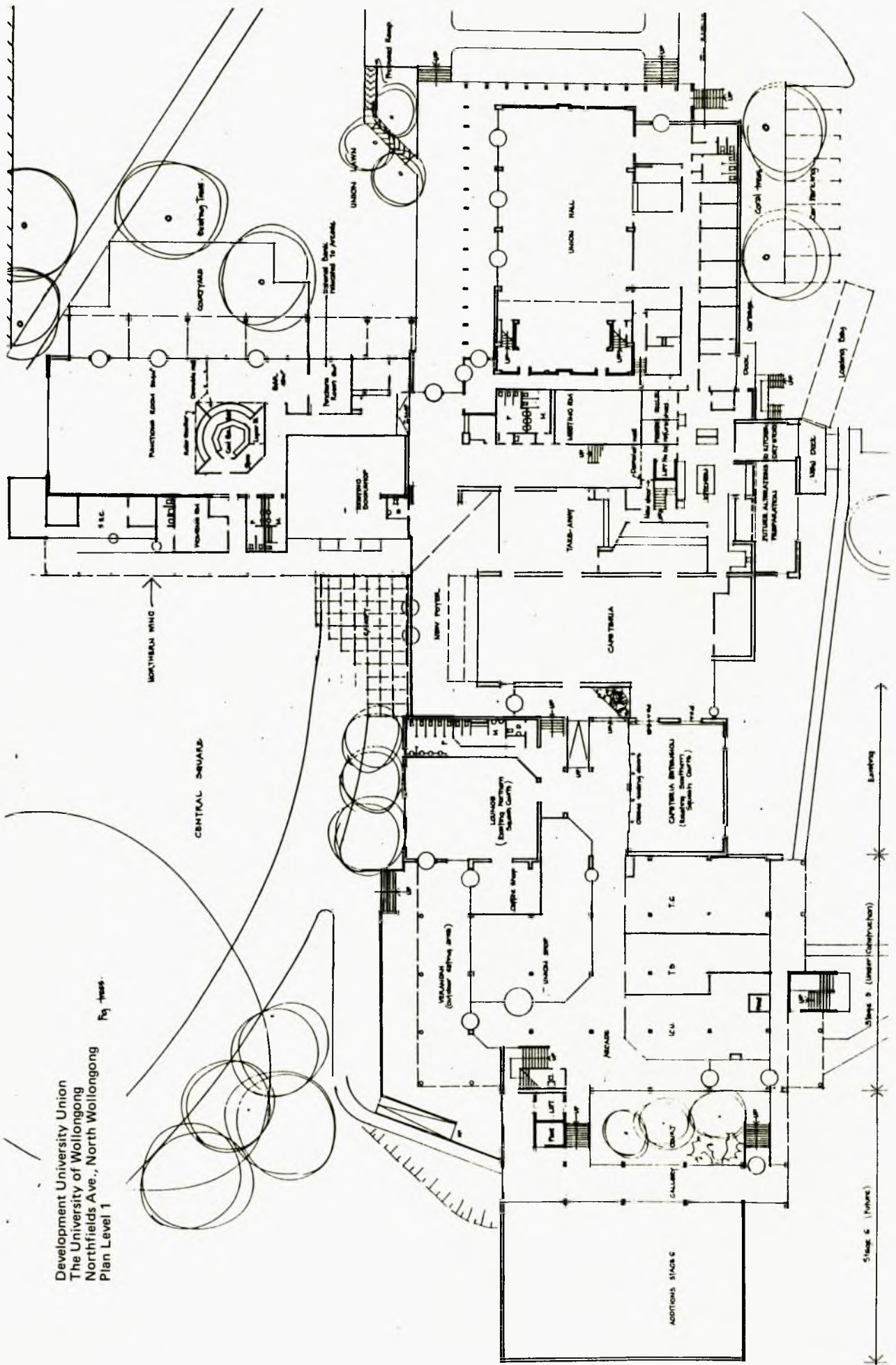

# THE UNIVERSITY OF WOLLONGONG UNION

## GENERAL REPORT

1986 witnessed a dramatic turn around in many areas of the Union's operations. Decisive action on a number of different fronts enabled the Union to provide better services in existing space limitations.

The catering operation of the Union was subjected to close and prolonged study and the resulting changes alleviated many of the overcrowding problems of the past few years. The opening of a new self-serve catering outlet, called the 'Weigh In' not only relieved crowding in the Cafeteria but cultivated a new clientele for the Union.

A reversal of the trend in recent years toward increased catering deficits was achieved by a combination of initiatives, including increased function trade and better utilisation of staff and physical resources. If the Union can sustain the performance levels of 1986, the future prospects for vastly improved physical facilities and improved services are very strong.

The Union Shop following a refit in January 1986 recorded a 97% increase in net profit. At the same time pricing policy enabled members to purchase stationery at a price comparable to even the biggest chain store.

Buoyed by improved performance in catering, the Union Shop, and in bar trading, the Union proceeded with confidence to commence construction of the commercial centre in September 1986. This new development, funded jointly by the University and the Union, together with a loan of \$1.00 m is a tribute to the dedication and loyalty of the staff of the Union, whose performance enabled the project to proceed, and to University/Union relations. Without the assistance and co-operation of the University, this project would not have materialised.

'Union Arcade' will provide many new services to the campus including a medical centre, pharmacy, hairdresser, travel agent, solicitors office and Credit Union branch. In addition, the Arcade will enable the expansion of existing services, including banking, the Union Shop (to be enlarged into a Mini Market) and student services, incorporating counselling, careers advice and accommodation services. A flexible conference room complex completes the Arcade.

The Union is not just concerned with commercial style operations and capital development programmes.

The activities programme provided both variety and excitement, with a comprehensive offering of social and cultural activities. A shift in emphasis to lunchtime entertainment was warmly received by the membership.

Kids' Uni, the Childcare Centre on campus, continued to provide the highest quality care with a fee scale commencing at 50 cents per hour. This centre, which does not attract any government financial support, is funded jointly by the University, the Union and the S.R.C. However, demand for places necessitates planning for a major expansion of the centre.

1986 has provided the Union with a solid base from which many innovative and exciting developments can arise. Projects such as the redevelopment of the squash courts to provide additional cafeteria space, a coffee lounge and links to the Arcade at both lower and upper levels, the development of a new bar and beer garden in the Northern Wing of the building, the fitting out of a new kitchen and conference rooms, and the improvement of access for the disabled will consume the accumulated surpluses of the Union.

Without surpluses of the magnitude generated in 1986 these developments would not be possible. Without the generation of surpluses in future years, further developments will not occur. Members can be confident that the Union Board of Management is aware of the need and has the determination to respond to that need.

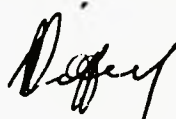

### NOTES TO & FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDED 31ST DECEMBER, 1986

#### 1. Statement of Accounting Methods

The accounting methods adopted by the Union are in accord with the accounting standards required by the Australian accounting bodies and/or by law. The accounts have been prepared primarily on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. Non-current assets have been written down to replacement value where required.

Set out below is a summary of the significant accounting methods adopted by the Union and, in particular, the accounting method adopted where there exists a choice between two or more acceptable methods.

##### a) Building Improvements

Amounts expended by The Union on Building Improvements are capitalised and written off over a period of 10 years.

##### b) Depreciation

Depreciation is provided on all fixed assets so as to write off the assets progressively over their estimated economic life. The straight line method of depreciation has been used.

##### c) Stock Valuations

Stock has been valued at cost. Cost is based on the first-in first-out principle and includes expenditure incurred in acquiring the stock and bringing it to the existing condition and location.

These bases of valuation are consistent with those of previous years.

##### d) Members' Fees

Members' fees are brought to account in the year to which the fees relate, and not necessarily the year in which the University of Wollongong, which collects those fees on behalf of the Union, remits them to the Union.

Entrance fees are included in members' fees.

##### e) Interest Income

Interest income is brought to account on an accrual basis.

##### f) Provision for Long Service Leave

Long Service Leave is provided for all employees, including part-time employees.

#### 2. Sports Association Subvention

The Union has in past years charged The University of Wollongong Recreation and Sports Association an annual fee to cover costs incurred by the Union in the administration of that body. As the Recreation and Sports Association has become an autonomous body no charge was made during the current year.

#### 3. The University of Wollongong

The University of Wollongong provides support to the Union by means of tenancy of The Union buildings and the salary and oncosts of the Secretary-Manager. The costs of this support have not been brought to account in these financial statements.

## 10. Wollongong Institute of Education

As from 1st January 1983, the former Wollongong Institute of Education has been administered by the University of Wollongong. The agreement relating to the transfer of the assets of the Wollongong Institute of Education Students' Association resulted in funds being invested by the Union in an account titled "Institute Capital Development Fund". This money, and interest earned thereon, can be used for any development project on campus approved by the Union Board of Management after the board has considered a recommendation by the Institute Students' Association for such use.

## 11. Capital Commitments

Contracts have been entered into by The University of Wollongong for the construction of a Commercial Centre adjacent to the existing Union Buildings. The estimated cost of this project is \$1,250,000, which is being financed from funds provided by The University of Wollongong amounting to \$250,000, and the borrowing by The Union of \$1,000,000.

As at 31st December 1986, the Building was under construction, but the expenditure incurred had not exceeded the contribution by The University of Wollongong. Arrangements for the borrowing by The Union had not been finalised at that date.

The expenditure by The Union on these buildings will be classified as Building Improvements and written off over a period of 10 years.

# Activities



1986 saw a continuation of emphasis on FREE LUNCHTIME ENTERTAINMENT. A highly varied offering made it possible to please 'most of the people often', and to present entertainment with which many members are unfamiliar.

EVENING ENTERTAINMENT was rationalised on Thursday nights confining major rock concerts to several well timed nights immediately following monthly TEAS payments. Remaining Thursday night entertainment was filled with soloists in the Southern Lounge in conjunction with a number of Swift and Moore promotion nights, alternating with the rock concerts and the enormously popular TALENT QUEST.

Several GUEST SPEAKERS gave lunchtime addresses in 1986 on topics ranging from human rights in South Africa, nuclear disarmament, women's rights, aboriginal land rights and bicentennial funding to the highlight of the programme, an address on civil rights in the Philippines by Columban missionary, Fr. Brian Gore.
