ASSOCIATION OF PROFESSORS FORMED

The University of Wollongong now has its own Association of Professors. The inaugural meeting elected the following officers:

President - Professor J.B. Ryan

Vice President - Professor A.C. Cook

Secretary/Treasurer - Professor J.R. Blake

Professors Fisher and Schmidt were elected to the Executive Committee which has responsibility for administering the affairs of the Association.

The Association's main objective is to promote and encourage excellence in scholarship, teaching and research at all levels in the University, and to strengthen the role of the professoriate and its contribution to the University. The feeling had emerged, partly as a result of the University's fast growth and current size, that important policy issues needed more consideration and a broader perspective. General meetings are intended to provide a relaxed atmosphere free of Departmental and other commitments where issues may be debated on their merits. While the Association is not a committee within the University's committee and decision-making structure, in appropriate cases it will put forward views for consideration.

A secondary objective is to monitor changes in conditions of employment relating to professors. It is stressed, however, that the Association is not an industrial union. That function clearly resides with the UWASA, and any industrial matters

will be taken up through that body.

Any person holding a chair in the University is eligible for membership, and honorary membership may be granted to professors who have retired from the University. Several retired professors have expressed enthusiasm about the formation of the Association, Professor Brinson writing, for example: "I feel sure that an opportunity to exchange views will be valuable" and Professor Brown stating: "I greatly look forward to attending appropriate gatherings of the Association".

We were delighted with the response to the first general meeting, following dinner in the Northern Lounge on July 17. Altogether 19 attended. Professor K.R. McKinnon, Vice-Chancellor, addressed the meeting on the Future of the University of Wollongong, and answered questions on the topic.

The Association has established working parties on Development of the University (Convenor: Professor J.B. Ryan) and Entrance Requirements (Convenor: Professor J.R. Blake) Comments from any members of the University will be welcome.

Education loses a tireless leader

The death earlier this month of the chairman of the Australian Vice-Chancellors Committee (AVCC), Professor Donald Stranks, leaves universities and the tertiary sector leaderless at a time when they are facing many problems, including declining funds.

Professor Stranks died in Adelaide. He was 56.

The Professor, who was about to begin his third term as Vice-Chancellor of Adelaide University, was highly regarded in academic circles and was showing growing confidence as chairman of the AVCC.

He had just returned from China and was preparing for a meeting of the Association of Commonwealth Universities (ACU) in Kuala Lumpur at the end of the week. He was on the ACU council.

Professor Stranks, a chemist, was educated at Melbourne High School and Melbourne University, where he gained his PhD.

He lectured at Leeds University, returned to Melbourne

and was Dean of Science at Adelaide University in 1968. He became Professor of Inorganic Chemistry at Melbourne in 1973, and moved to the vice-chancellorship of Adelaide four years later.

He served on the Australian Research Grants Committee, was foundation chairman of the National Nuclear Magnetic Resonance Centre in Canberra, was chairman of the South Australian Council on Technological Change since 1981, was chairman of the board of the Australian American Education Foundation, and was a visiting professor to a number of universities.

He became chairman of the AVCC at the beginning of this year and was seen as enhancing Australia's standing overseas.

The secretary of the AVCC, Mr Frank Hambly, said that he was one of the most respected and influential Vice-Chancellors. He was well liked, and people were looking forward to the work he was going to accomplish.

NATIONAL INTEREST IN THEORY OF LEARNING

A theory of learning developed by staff of the Centre for Literacy, Language and Cognition is attracting interest at the national and international level.

The theory, which is based on the principles which make learning to control the oral form of one's native language so spectacular and successful, has been researched in local schools by Dr Brian Cambourne, Mr P Geekie, Ms J Turbill, Ms J Hammond, and Mr W Winser for the past two years. A teaching methodology for helping children get control of the written form of language has been developed and successfully put on trial.

At least four states have included versions of the theory in recently published syllabus documents and a version of it was presented at a recent International ESL Conference in Singapore.



QUOTA INTERNATIONAL INC. BICENTENNIAL COMMUNITY SERVICE AWARD FOR YOUNG WOMEN

As part of the Australian bicentennial celebrations, Quota in Austalia wish to give recognition to young women in the community who give their time voluntarily in community service.

Quota have now established the Quota International Bicentennial Community Service Award. The award will recognise service given by the entrant on a local, state or national level. The Quota Clubs of Wollongong and Port Kembla have combined to promote the Award in the Illawarra.

The Award is being conducted Australia wide through Quota, an International service organisation that has long supported young people through scholarships, school emergency funds, support for school libraries, student of the year awards, riding for the disabled, youth shelters and refuges, assistance for the unemployed, youth camps, and areas of specific need, including handicapped children and those with hearing and speech impediments.

The Award is open to young women between 18 and 25 years of age, who are involved in any area of community service — service to elderly, underpriveleged, or youth and sporting activities, drama groups, music, guiding and scouting — any voluntary community involvement. Every entrant will receive a certificate of appreciation for her work.

The national launch was held in Geelong, Victoria, on June 6. To begin the selection of an Illawarra entrant for the national Award, a civic launch was given by the Lord Mayor Frank Arkell, on August 12.

The Illawarra entrant will be chosen from entries received up to March 1987. The winner of the Illawarra judging will go to the Quota Clubs 35th District judging in August 1987 and the District winner will enter the National judging in March 1988. The National winner will be honoured at the International Convention of Quota, to be held in Melbourne in July 1988.

FELLOWSHIPS FOR PRESENTATION OF SEMINARS IN CHINA

Mr Hai Yap Teoh and Dr Victor Wan from the Department of Accountancy and Legal Studies have been awarded Visiting Fellowships by the Australian and Chinese Academies of Social Sciences to visit China in September 1986 in order to deliver academic papers in accounting and finance at the Central Research Institute of Banking and Finance in Beijing and the Shanghai Research Institute of Finance and Economics.

BUSINESS COUNCIL OF AUSTRALIA: REPORT ON EDUCATION

The Business Council of Australia has carried out a nation-wide survey of Australia's top 80 companies to establish the attitudes of business to education.

The results showed university graduates are more likely to have the qualities required by business than graduates of other tertiary institutions or school-leavers.

Their survey found that:

- university graduates have the ability to solve problems, make decisions and work independently,
- . they are more likely to have personal motivation and ambition,
- . other skills highest in university graduates were punctuality and attendance, deportment and manners, general knowledge and oral communication,
- business attaches importance to the results created by formal education especially the capacity to think and solve problems and the learning of vocational and professional skills,
- there had been an improvement in the quality of university graduates especially in the areas of decision-making and the use of technology.

The Business Council saw a role for it to play in the future of educational planning. It recommended that business:

- . advise educational authorities of the kinds of skills and understandings which are most needed in the workplace,
- . alter its own training programs so they may best complement those of formal education.
- . seek to influence education decision-making so that graduates of the system are better placed to fit into the workplace, and,
- . join in with education authorities in co-operative projects.



ADVERTISING POLICY CHANGES

One of the strategies proposed in the EEO Management Plan (strategy 1.6) concerned ensuring that the system of advertising job vacancies is consistent with equal opportunity principles.

It suggested widening the field of eligible applicants and possible abolition of the system whereby all general staff vacancies below the level of Senior Administrative Officer were offered internally first, and then externally only if an eligible applicant were not available.

At its August meeting, Council endorsed the abolition of this policy in favour of concurrent internal and external advertising of all job vacancies.

Since the principle of merit is the key to all equal opportunity programs, and since merit is based on open competition, this is a great advance for the University in its implementation of EEO practices.

Recruitment systems which truly improve the access to employment of a wider range of people with ability must be highly commended.

At the same time, the University is committed to the development of schemes which give current staff scope for widening their skills and abilities so that they can compete for vacancies as they occur.

To this end, job rotation opportunities will continue to be available for short-term vacancies and are covered within the terms of the Council resolution.

As well, a range of staff training initiatives have been stepped up which provide current staff with extra skills to compete for positions as they occur.

Finally, Selection Techniques training has begun for those wishing to serve on selection committees and this too should help ensure the fair assessment of applicants based on job related criteria.

This 'package' of activities indicates a welcome acceptance of the principles underlying equal employment opportunity, a commitment which will benefit not only individuals who may previously have been denied access to opportunities, but the efficiency of the University as a whole.

The exhibition of jewellery, paintings and photography held in the Long Gallery must rank as one of the more notable ever staged by the School of Creative Arts.

The bringing together of three disparate disciplines in one exhibition might seem to present an odd mix. Yet, in observing the exhibited works it becomes apparent that painter Kouto and photographer Waite share a consuming interest in landscape. Kouto works in colour, depicting, sometimes eerily, the landscapes of the southern hemisphere. She also explores the human figure.

The work displayed by Bernard Eveleigh embrace a tenyear period, from pieces he designed and made while at the Central School of Art Design in London to his most recent range of brooches. His work displays considerable versatility—even the use of coloured titanium.

AUSTRALIAN ACADEMY OF SCIENCE MEDALS

1987 THOMAS RANKEN LYLE MEDAL

The Lyle Medal commemorates the contribution of Sir Thomas Ranken Lyle, FRS (1860–1944) to Australian science and industry generally and in particular to his own fields of science, physics and mathematics.

The Medal is awarded not more than once every two years. Its purpose is to recognise outstanding achievement by a worker in Australia on the basis of research in mathematics or physics. Work carried out during the whole of the candidates' careers may be taken into consideration but special weight will be given to recent work.

A new book on the controversial Australian journalist and war correspondent, Wilfred Burchett, edited by a Lecturer in History and Politics at the University of Wollongong, Ben Kiernan, was successfully launched in London recently. The Literary Editor of *The Times* placed *Burchett: Reporting the Other Side of the World, 1939–1983*, high on his list of "interesting books published this week" (18 June 1986). *Time Out* called it an "admirable book", and the *New Statesman* commented: "This book is as near as we are likely to get to the final word on one of the most remarkable journalists of all time." The book was also well received in the regional UK press.

In the *Sunday Times* review, Andrew Boyle, author of *The Climate of Treason*, wrote: "It is a pity that Burchett has received less attention than he deserves here in Britain. For many years immense efforts have been devoted to the slippery task of trying to prove that he was either a Soviet spy or a Korean agent. The Australian establishment sought to take away his passport and by other means to tell the world that he was *persona non grata*, but there is still no firm indication of his complicity. It is possible that, as John Pilger who writes the preface claims, he was merely more sinned against than sinning. Without question, Burchett's talents were as definitive as his life-style was complex. He always tended to go along with the underdog, being the quiet introvert he was. His courage was considerable."

Burchett has now been published by Australasian Publishing Company, Sydney.


THE BLACK ROCKS REEF

'The Black Rocks which I have mentioned in my rambling story was the name by which a reef of rock at that point was known. My early memory of the reef bears very little likeness to the present view of the same area now.

'The building of the dressing sheds and the baths, together with the removal of the high sandhill along the seafront, has certainly had a very big effect on the local scene.

'My early memory of the reef was when it stood well above water level and it was possible to climb out along it at low tide and the many little rock pools left by the falling tide, contained many very small fish. Crabs were plentiful, but dashed away as we approached and took refuge in the crevices in the rocks. Periwinkles and a type of barnacle were clustered on many of the rocks and the sandhill stood high above the beach level.

'In later years, the P.W.D. quarried much of the reef which was used in roadmaking, and very little remains now.

'On the 8th October 1880, during the hours of darkness, the 'Queen of Nations' carrying general cargo and passengers from England, ran aground on the reef and became a total loss. Reports of the incident, published at the time, say that she came in on a high tide and finished up almost on the beach. The Captain, the report continued, had mistaken the fire in the slag heap at the local mountainside mine for the signal light at the entrance to Sydney Harbour. A farewell party was being held on board at the time to celebrate the end of a long journey and to say goodbye to people they had lived with for so long within the confines of the ship, and in many cases were unlikely to meet again after leaving the ship on the morrow.

'John Madden, whose home was at the head of Tarrawanna Lane, was sent for. He was a diver by trade and had built many of the local jetties and bridges. He was in hopes of being able to float her off on the high tide, but a very heavy sea was building up, with water breaking over her, and he realised that she was in danger of breaking up.

'The passengers had all been brought ashore, and as a crowd of sight-seers was on hand, he decided to salvage as much of the cargo as possible. Many of these helpers, after the cargo was landed, were busily engaged, it is said, burying smaller articles in the sandhill for later recovery, but in many cases on their return it was to find that the article had already been removed, even though police had been called and were patrolling the beach.

'The ship became a total loss and broke up very quickly. Mr Fred Zeims, in whose yard she had gone aground, so to speak, was one of those early on the scene and he reported that when he first saw the wreck in the morning light, she was sitting close inshore and with a heavy list to port and the big sea which had built up causing her to pound heavily on the reef. Fred Zeims would, I feel sure, be one of the very few, or perhaps the only person, to have had a ship wrecked in what had once been his back yard.'

CALTEX WOMEN GRADUATE SCHOLARSHIP AND PRIZES

A Scholarship Scheme has been extablished be Caltex Oil (Australia) Pty Limited for postgraduate studies for Australian women. The first awards in the scheme were made in 1977 and the basic conditions remained unaltered until 1983. With the significant increase in costs in postgraduate studies overseas, and in particular in the United Kingdom, it became necessary for the conditions of the Caltex Scholarship Scheme to be substantially revised.

The current arrangements for the administration of this scheme involve the award of one National Scholarship valued at \$44,000 in addition to six other State Prizes valued at \$5,000 each. The holder of the National Scholarship is selected from the winners of the State Prizes and thus the principal award is valued at the very significant sum of \$49,000.

Closing date September 26.

WALTER BURFITT PRIZE 1986

The Prize known as the Walter Burfitt Prize was established by the Royal Society of NSW as the result of a generous gift to the Society by the late Dr W.F. Burfitt, BA, MB, ChM, BSc, of Sydney, which was augmented later by a gift from Mrs W.F. Burfitt.

- The Walter Burfitt Prize shall be awarded at intervals of three years to the worker in pure or applied science, resident in Australia or New Zealand, whose papers and other contributions published during the past six, years are deemed of the highest scientific merit, account being taken only of investigations described for the first time, and carried out by the author mainly in these Dominions.
- 2. The prize may be awarded to two authors working in collaboration.
- 3. The prize is \$500.

The 20th award will be made for work published during the six years ended December 31 1985. Nominations and publications should be submitted to the Royal Society of New South Wales not later than September 30 1986.

CLARKE MEMORIAL MEDAL 1986

The Royal Society of New South Wales intends making the triennial award of the Clarke Memorial Medal in the field of Geology, in all its aspects.

The formal conditions of the Medal are that it be awarded for distinguished work done in, or on, the Australian Commonwealth and its territories.

The Medal was founded in 1878 soon after the death of the Rev. W.B. Clarke in appreciation of his character and services 'as a learned colonist, a faithful minister of religion, and an eminent scientific man'. He was a Vice-President of the Royal Society of NSW from the time of its formation in 1866 until the time of his death.

Nominations are required by September 30.
