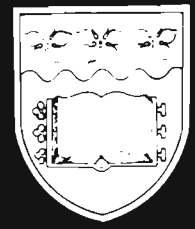

Wildlife exhibition – Custom-made

A WILDLIFE exhibition with a difference is being held at the Wollongong Science Centre.

Called *Seized*, the exhibition displays items of endangered and threatened species from around the world seized by Customs Officers under the Wildlife Protection Act.

There are also many products made from the skins and shells of endangered

species. The Customs exhibition was launched in the Australian Museum in Sydney more than a year ago. It has been touring most Australian states since, making the dramatic plea for travellers to help slow the senseless slaughter of endangered creatures by refusing to buy stuffed wildlife or products made from them.

The centrepiece of the exhibition is a

2.5metre tall North American grizzly bear brought into the country with the personal effects of a man transferring to work in Australia.

There are also skins of the big cats, an elephant and a rhino footstool, giant snake skins, intricate ivory carvings, and even a turtle shell guitar. A feature is the suitcase used by a bird smuggler attempting to take native Australian parrots overseas for sale on the black market.

Seized was opened by the Collector of Customs for NSW, Jim Conlon.

"No-one can see the result of such senseless killing and the greedy trade in wildlife without agreeing that we must leave the wildlife where it belongs," he said.

Mr Conlon said that the penalty for trading for protected or endangered wildlife was up to five years imprisonment or a maximum fine of \$100,000.

The exhibition will be at the Science Centre for at least two months and is open 1-5pm each day during the school holidays.

Brief News

STUDENTS of Industrial Relations and academics involved in presenting the course have formed a Wollongong University Industrial Relations Association.

The elected student executive are Valli Beattie (President), Lyndal Dean (Vice President), Galay Ramia (Treasurer), Peter Logan (Secretary).

This new association will liaise with industrial relations practitioners and societies to gain further insights into the field.

THE Department of Civil and Mining Engineering has attracted further research funding from the NSW Education and Training Foundation for a project in conjunction with the materials and minerals industries to provide interactive computer based training modules for safe production with bins, conveyors and crushers.

The \$242,000 research project, proposed and to be co-ordinated by Dr Denis Montgomery, has received wide support from industry, including the Institute of Quarrying, Australasian Slag Association and associated member companies. ETF and Industry will provide funding of \$84,500 and \$104,000, respectively, during the 18 months duration of the project.

THE Department of Management is holding a careers day on Tuesday, October 22 to create an awareness of marketing among the undergraduate business and commerce students.

THE National Housing Authority of Thailand sent 46 executives for a seven-day training program in Australia this month.

The program included a visit to this University to meet those involved in the Structural Engineering and Construction Research Program in the Department of Civil and Mining Engineering.

At a function to welcome the visitors the Vice-Chancellor was presented with the figure of a mythical god which represented power and prosperity.

At its full meeting recently, the AVCC, which represents Australia's universities, endorsed a working party's proposals on credit transfer.

Credit transfer is a system where studies previously undertaken or work experience gained can be credited towards a degree.

AVCC president, Professor Ken McKinnon, said the AVCC has pledged a substantial amount for the pilot project. This would reflect an initial grant from the Department of Employment, Education and Training.

"We believe the higher education institution themselves must be the final custodians of credit transfer," he said.

PROFESSOR Jennifer Seberry, from the Australian Defence Force Academy, has accepted appointment as Professor of Computer Science.

Professor Seberry was born in Sydney and obtained her BSc in 1966 from the University of NSW. Her MSc and PhD were awarded by La Trobe in 1969 and 1971 respectively.

She was Professor and Head of the Department of Computer Science at University College, Australian Defence Force Academy.

Especially interested in authentication and computer security, Professor Seberry and her colleagues have received considerable media attention for their ATERB financed research into "anti-hacking systems" or *User Unique Identification*.

Professor Seberry will take up the appointment in the second half of 1992.

THE Christopher Columbus Consortium (CCC) program, a partnership consisting of the Faculty of Education, K-12 schools and Apple Computer Inc., is becoming well established at Keira Technology High School.

The purpose of the consortium is to promote effective applications of computers and related technologies in education.

Two members of Keira High's science faculty, Barry Baird and Gwyn Brickell, are directly involved with members of the Faculty of Education in developing an interactive multimedia software package relevant to the science education curriculum in junior and senior high schools.

Both teachers and Associate Professor John Hedberg, were invited to attend the CCC annual conference in San Jose, USA in July.

University, FMWU sign agreement

THE Federated Miscellaneous Workers Union of Australia (FMWU) and the University of Wollongong have negotiated an agreement to employ intellectually disabled individuals in appropriate positions.

The initial target is the employment of four such people in cleaning positions in the six months from the signing of the agreement.

At the end of 12 months the parties will review the future target for subsequent years. The aim is to expand the numbers in cleaning and expand into other areas.

Essential Personnel Employment Agency, an organisation dedicated to matching intellectually-disabled people with jobs, will put forward the names of possible participants in the employment program and participate in appropriate training for these people and their induction into the workplace.

Establishment of University audit committee

AT its August meeting, the University Council established a University Audit Committee in accordance with the guidelines provided by the Auditing Standards Board of the Australian Accounting Research Foundation.

The Board defines an audit committee as: "a committee comprising a majority of independent/non-executive members of the governing body of an entity to which has been assigned, amongst other functions, the oversight of the financial reporting and auditing process".

An audit committee should:

- comprise a majority of independent/non-executive members of the governing body with no operating responsibilities;
- include an executive member of the governing body so that it is directly informed of that body's views, the independence of the committee will be enhanced if the executive member is not directly involved in the financial functions of the entity;

- have continuity of membership;

- have qualifications for membership which reflect those appropriate for membership of the governing body, while it would be appropriate that at least one member of the committee have a strong financial background, the overall composition of the committee should reflect a broad experience and knowledge base.

In accordance with the above guidelines, Council elected the following members to the University Audit Committee: Rod Oxley (Chairperson), Robert Somervaille, Shirley Nixon and Professor Lauchlan Chipman

The committee held its first meeting on September 12 to determine its precise terms of reference for submission to Council's next meeting.

The Permanent Collection has been built up with modest annual funding but much love and care.

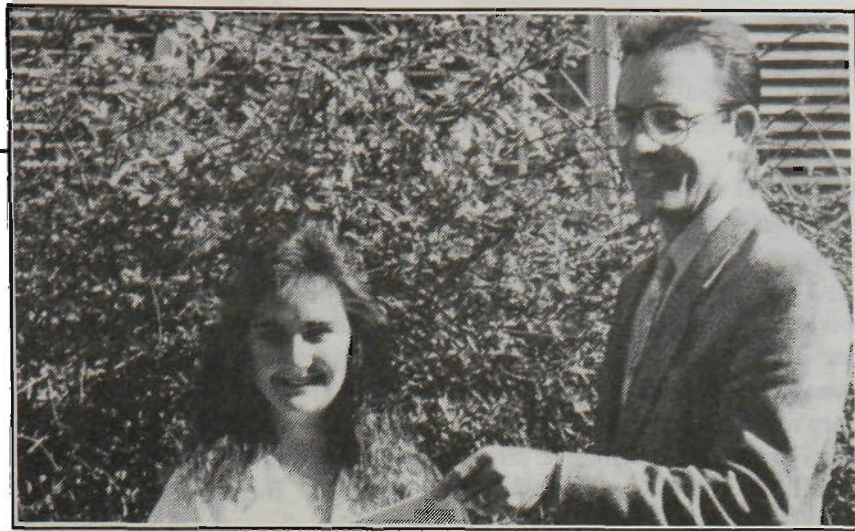
