## International law competition comes to Australia . . .

The University of Wollongong has been nominated as the Australian representative in the 1992 Client Interviewing competition for law students to be held in Portland, Oregon on 29 March.

Wollongong will be the first university in Australia to become involved in this competition. In the past, the International Competition has involved representatives from the United States, England, Scotland and Canada.

Local solicitor Mr Peter Kell has provided the funds to enable the students to travel to Portland.

Later this year, an inaugural Australian competition will be hosted by the University of Wollongong to select a team to compete in the international competition in 1993.

All Australian law schools will be

invited to enter one team (comprised of two students). To date 12 law schools have expressed an interest in participating in the competition.

The 1993 competition will be held in Calgary, Alberta, Canada in April.

The Client Interviewing Competition began in the United States approximately 20 years ago.

The original idea was to develop a form of skills training exercise to pro-

mote a client-centred form of legal service.

The notion of a competition was borrowed from the conventional moot court exercises which for many years have been common in law schools in the United States and elsewhere.

While moots are primarily designed to focus on appellate advocacy, a form of practice in which only a small element of the profession engages, the client interviewing competition is concerned with an activity which most practising lawyers undertake on a daily basis.

The competition is designed to provide a forum for the development of interviewing and counselling models which can be carried into practice.

## Brief News

Peter John Maguire, a PhD student in Physics, is the successful nominee for the St George Youth Endeavour Award 'Tertiary Academic' for this quarter.

A presentation took place on 19 March at the North Beach Park Royal.

The prize was a St George Youth Endeavour Award certificate, \$100 St George savings account and dinner for two at the Harbourfront Restaurant.

Larry Blackett, a Senior Lecturer in the Department of Accountancy, has been continuing his involvement in the Professional Development activities of the Australian Society of Certified Practising Accountants.

Along with Alan Bridges he conducted a day long programme for financial controllers in Sydney in February. The programme was entitled Financial and Managerial Control Systems.

In March he conducted a similar workshop with Alan Bridges and John Petty. This workshop was entitled Your Management and Control Systems - Your Survival, and is part of CONGRESS 92. This congress incorporates the National Public Practice Convention and the NSW State Congress of the Australian Society of CPAs.

Professor Peter Fisher, Head of the Department of Physics, resigned recently as the President of the Australian Institute of Nuclear Science and Engineering (AINSE) which co-ordinates the use of the unique national nuclear facilities at the Lucas Heights Research laboratories.

# Dr Steel brings a strong statistics background

Dr David Steel was appointed to the Department of Mathematics, Faculty of Informatics, in January this year as a senior lecturer.

He accepted the position at the University of Wollongong so that he could pursue research and consulting as well as teaching, particularly in the areas of survey design and analysis, analysis of multi-level and aggregate data, small area estimation and geographic information systems, non sampling errors and quality in statistical collections.

He was previously Assistant Statistician, Industry Division, Australian Bureau of Statistics, Canberra.

In this position he was responsible for a range of economic statistics covering areas such as the retail industry, professional and business services, personal and tourism related services, science and technology (including R&D), small business and economic indicators such as investment, stocks and company profits.

His branch also undertook surveys on topical issues in industry, such as manufacturing technology, waste management, investment and exports.

Before this he was director of the group providing all the mathematical statistical services to the social, labour and demography division within the ABS.

This involved developing the sample

design, estimation and analysis procedures for a large range of surveys, including the ABS's main household survey, the monthly labour force survey and the household expenditure survey.

He was also involved in the quality control and evaluation program for the population census.

He has undertaken research into a method of producing estimates from sample surveys for small geographic

areas, non-sampling errors in statistical collections, time series methods in the design and estimation of repeated surveys, use of telephone and other methods in sample selection and data collection.

David Steel graduated from the University of Adelaide with an honours degree in mathematical statistics in 1974.

He obtained a MSc in Statistics from ANU in 1978. A Commonwealth Government overseas study award in 1982 enabled him to obtain a PhD in Statistics from the University of Southampton in 1985. His thesis was concerned with analysing individual and aggregate level survey and other data with a hierarchical structure.

He has found that as a statistician you get a wide view of the world.

He has worked on surveys on topics ranging from accountancy to zoological gardens, and with many organisations including the Bureau of Agricultural Economics, the Industries Commission, The National Heart Foundation, the Cultural Ministers Council, the national statistical offices of Thailand, Vietnam and Malaysia.

## Bradlow on ARC Collaborative Research Grants Panel

Professor of Computer Engineering within the Department of Electrical and Computer Engineering, and Director, NorTel Technology Centre, Professor Hugh Bradlow, has been appointed to the Australian Research Council's Collaborative Research Grants Panel.

The Minister for Employment, Education and Training, Kim Beazley, has approved Professor Bradlow's appointment by the National Board of Employment, Education and Training as a member of the panel until 31 December 1994.

Professor Bradlow is the first academic at Wollongong to be appointed to an ARC Committee.

The panel's role is to assess submissions for Collaborative Research Grants, a new grant scheme instituted this year by the ARC, which is intended to foster collaboration between universities and industry.

The grants are intended to support individual collaborative projects as opposed to an entire program, the latter being the mandate of the Cooperative Research Centre. These grants are available in any discipline.

## Mozart and Strauss get together

The City of Wollongong Symphony Orchestra will present its first subscription concert for 1992 on Saturday 11 April.

The programme for this pair of concerts is Viennese – music by Mozart sharing the bill with well-loved 19th-century dance music from the waltz kings: Josef Lanner, Johann Strauss (Senior and Junior) and Josef Strauss.

Mozart is represented by the overture from his opera *Il Seraglio* and the Emperor among his piano concertos, the C-major K.503, in which the soloist will be the visiting Scottish pianist Roy Howat.

The second half of the programme will bring such Viennese favourites as the waltzes *Wine, Women and Song*, *Where the Lemon Trees Bloom*, the *Pizzicato* and *Thunder and Lightning* polkas.

# Co-operation needed to help out Printery

The resources used by the Printery in printing jobs for the various University departments are relatively fixed.

The equipment and staff are considered necessary to provide a high level of service to users at most volume levels.

No jobbing factory can afford to provide the equipment and staff to cater for maximum or peak demands as these additional facilities would be underutilised most of the time.

As has been the trend in recent years, the Printery is experiencing very high work loads at the start of Autumn Session whereas the work loads in December 1991 and January 1992 were considerably lower.

It would obviously be desirable to try to even out the peaks and troughs. This would not only provide a more even work load for Printery staff and equipment but would also provide a better service to users in that the Printery would have a better chance of meeting all date deadlines.

Despite making every effort to cope with the current high work load by using casual staff and considerable overtime, the Manager, Glen Brissett, regrets that on occasions they have been unable to meet some current job deadlines.

While all in the Printery will continue to make every endeavour to provide a high quality efficient service to University users, they suggest that planning printing requirements before a session would benefit all concerned.

To try to overcome peak work loads Mr Brissett is considering the implementation of a policy that would give priority to jobs received at the Printery by a date well before the start of each session.

For Spring Session the production plan would be as follows:-

Print requisitions entering the Printery before 20 June 1992 and that are required for delivery in the first week of the Spring Session will be given priority production time and will be eligible for a five per cent discount.

Print requisitions entering the Printery after the 20 June 1992 for delivery at the beginning of Spring Session will be produced in the order in which they are received at the Printery.

This system will benefit well planned print projects and will not alter the Printery's goal of providing quality service, economy and flexibility to print users.

Students, in teams of two, conduct a 30-minute interview.

Several days before that interview, the team is given a short 'office memorandum', indicating the nature of the problem which will form the basis of the interview.

Typically, the details are sketchy, although the team would know the general area of law to be involved (e.g. a commercial contract dispute).

The team interviews a 'client', (usually an actor) who has been provided with a synopsis of the problem (usually several pages or so); he or she might also be provided with any relevant documents (eg. a contract or a demand letter).

In essence, the team must endeavour

to ascertain the nature of the problem, the various possible legal and non-legal implications, and must begin the process of structuring a solution to the client's problem.

After the interview, the team reflects on the interview, the nature of the problem and any follow-up work to be done.

The criteria for judging emphasise the process of interviewing, including the use of effective questioning, the ability to elicit relevant information in an efficient way, the ability to ascertain the client's goals, the structure of the

interview, the ability to communicate with the client in a clear and effective fashion, and related matters.

In short, the competition criteria focus on the team's skill in building a good working relationship.

Bruce Ziff, of the Faculty of Law at the University of Alberta, is visiting at Wollongong until July.

He has been involved in the Canadian program for several years and will be assisting in the organisation of 1993 international competition.

The University of Alberta won the 1990 competition.

# Information Technology Purchasing Policy

The Computer Policy Committee has initiated a review of the University's Information Technology Purchasing Policy (ITPP).

This was prompted by claims that the present policy inhibits sensible and financially prudent purchasing, and causes commitments to servicing arrangements that are of little or no benefit.

These concerns were drawn to the attention of the University Council at its first meeting this year.

Others maintain that the present policy should be reaffirmed as providing the most cost-effective array of services to the University overall.

When the policy was originally approved, copies were sent to Deans, Faculty Officers, Heads of Units, the Library, and Financial Services.

At its 2 March meeting, the Computer Policy Committee established a working party consisting of the Pro Vice-Chancellor (Chair) Associate Professor Greg Doherty, and Mr Naimo, to consider submissions in relation to the present policy, and to report to the next meeting of the Computer Policy Committee, on Monday 13 April.

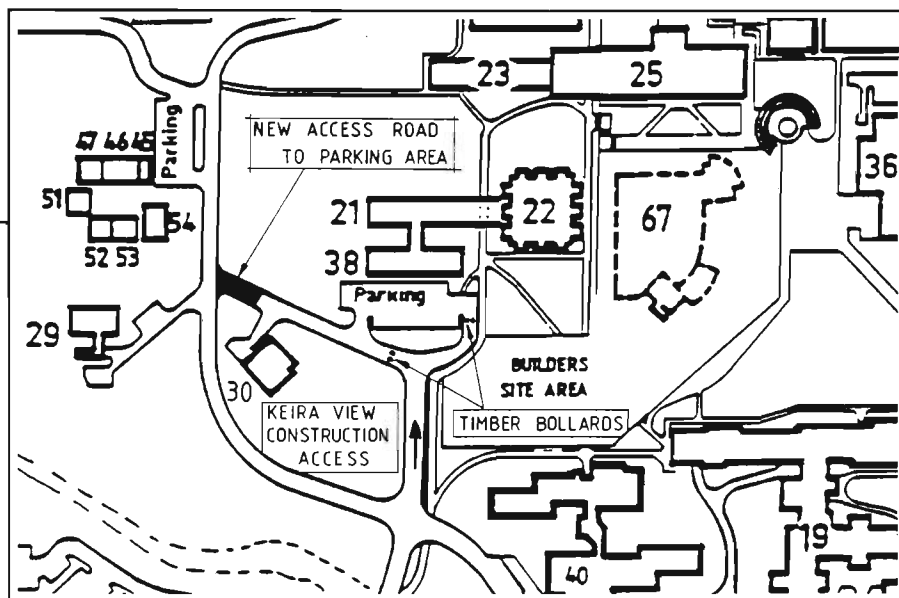
That meeting will then issue a green paper on its recommendations for future policy should for further discussion within the University and a final recommendation to the Vice-Chancellor.

Accordingly, submissions are invited on the policy.

Mr Naimo and/or his staff are available on request to visit and explain the present policy to units, and to answer any questions.

The closing date for submissions in this first round is Friday 3 April.

The working party will also be initiating visits to selected units and interviews with users who have already voiced considerable interest.
