## TASC ANNUAL REPORT HIGHLIGHTS

The Centre's Annual Report highlights the extraordinary growth over twelve months of this unique research, training and consultancy centre. The report details the variety of research and contract projects currently being undertaken by the Centre.

These include the impact of new technologies on the retail sector, of CAD/CAM on the manufacturing sector, of video technology on the information sector, and of trends in data storage systems on government policy.

In addition, major technology policy studies were undertaken for the WA, NSW, Victorian and Federal Governments, including the making of a film on the impact of new manufacturing technologies.

In releasing the Annual Report, the Co-Directors of the Centre, Professors Ron Johnston and Stephen Hill, announced plans for the future development of the Centre:

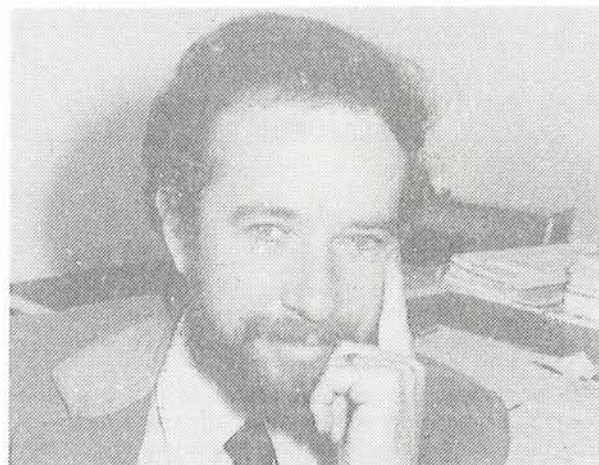
"While we can be satisfied in having notched up \$1/2 million in contract work in our first twelve months, we are looking at new directions for future growth.

We have just commenced a three year training program for high-level government officials in ASEAN and Australia under the ASEAN Science and Technology Policy Program. This has already given us an important international presence, and we think it will lead to exciting new international work.

We are also developing a system of outposts of the Centre, which will eventually give us a presence in Sydney, Melbourne and Canberra."

Professor Johnston added that he was extremely excited about two other ventures of the Centre, one of which would contribute to the solution of the economic problems confronting the local economy, while the other would open up the opportunity for the Centre to influence trend-setters in the use of technology within the Australian economy.

"Our aim is to provide an informed analysis of the issues and problems associated with contemporary technological developments. We are fulfilling this by moving forward in ways not normally associated with University Centres. The concerns are too important to take a traditional approach to communication. In line with our own philosophy, we are acting not reacting."

### TASC ADVISORY COUNCIL INAUGURATED

On 14th March, the first meeting of the Advisory Council of the Centre for Technology and Social Change was held at the University of Wollongong.

Present at the meeting were Mary Gaudron QC (Solicitor General NSW), Dr. Roy Green (Deputy Secretary, Department of Science), Mr. Stephen Jones (Chairman, Austgen Bio-Jet), Robyn Williams (ABC Science Show), Mr. Peter Wilson (Chief General Manager, Commonwealth Bank of Australia).

University representatives on the Council also attending the meeting were Professor Ken McKinnon, the Vice-Chancellor of the University of Wollongong, and Dr. Jim Falk, Professor Stephen Hill, Professor Ron Johnston and Daniel Rowland, of the Centre.

Mr. Gratton Wilson (Executive Secretary, CSIRO), Dr. Anne Summers (First Assistant Secretary, Office of the Status of Women), and Mr. Laurie Carmichael (AMWU) were unable to attend the meeting.

Special Guest, Dr. W.J. McG Tegart, Secretary of the Department of Science, addressed the members at a luncheon held at the University.

The Advisory Council was established to advise the Vice-Chancellor on future directions for the Centre for Technology and Social Change.

This inaugural meeting also allowed members of the Council to meet with the Research Fellows and members of the Centre.

## SENATORS TO VISIT TASC

Five Senators on the Senate Committee of Science, Technology and the Environment will be visiting the Centre for Technology and Social Change on Tuesday 2nd April.

The purpose of the Committee's visit is to take formal and informal evidence in support of the Centre's submission late last year regarding the Committee's Inquiry into New Technology and Employment.

In its submission, the Centre concentrated on the need for an appropriate system of technology assessment within Australia.

## NEW STRATEGY OF THE NATIONAL ENERGY RESEARCH, DEVELOPMENT & DEMONSTRATION COUNCIL

NERDDC has written to the University outlining a change in emphasis in its research funding objectives. Extracts from the letter are as follows.

"In particular, Council now wishes to place additional emphasis on a wider dissemination of results to industry. Council will of course, as indicated in the guidelines, continue to recommend projects for which technology transfer activities are not relevant. However, in this letter I wish to concentrate on those projects which are of interest to industry.

It has been one of the tenets of the Council throughout the Program that research results should, wherever appropriate, be taken out of the laboratory and into the market-place. In past years, the Program has included a number of activities to achieve this objective.

The results have been encouraging, and there has been a number of successes in technology transfer. I would refer particularly to the development of the Coalscan system for control of coal preparation, the development of methods for methane drainage for enhanced productivity and safety in coal mining and a number of developments in energy conservation and building practices which have found a place in several Australian industries.

Council has considered these and other successful examples of translating research results into practical achievements and has decided that special emphasis will be placed, in the 1985 round and in future years, on technology transfer.

We have looked closely at the experience of the Program in the past in achieving successful technology transfer. Council has noted that success is more likely in those areas of research where there are strong links between researchers and potential users of research results in industry. From an industry viewpoint, such links can result in the direction of research effort towards identified energy problems and areas where commercial potential exists.

In the light of this experience, Council considers that a new emphasis is justified in this area, and steps have been taken to stress further the importance of industry/

research links in the application procedures for the current round. However, the process of establishing such links cannot be done by the Council or by researchers acting alone. We believe that an effort is required by industry and research bodies at an institutional level to encourage the type of involvement we now seek.

Accordingly, I am writing to advise you of our views on this subject and in particular of the avenues provided under the Program for co-operation between industry and researchers.

- . Given the rise of consulting companies attached to research institutions and organised industry research groups, it should now be possible to establish a greater number of links and contacts for many classes of energy research in an organised fashion.
- . Council encourages wherever possible the submission of grant applications by private industry bodies, whether companies or research associations, incorporating research by public sector institutions on a sub-contract basis.
- . The 1985 Program guidelines re-emphasise Council's interest in joint applications, that is, applications by public sector organisations (Universities, CSIRO, CAE's) which reflect an industry interest in and/or commitment to a research project at the outset.
- . Council has asked 1985 grant applicants to indicate whether industry interest in their proposal has been expressed, and the extent of any links which may have been established.
- . Council sees particular value in applications which require secondment of researchers to industry for certain periods. Our guidelines encompass granting salary support payments for this purpose."

NERDDC has also informed the University about its priorities in this round of fund allocations. These are as follows:

### High Priority

- . Energy conservation technologies related to liquid fuels, including those in fields where specifically Australian or regional conditions are important.
- . Production of liquid hydrocarbon fuels from natural gas or from synthesis gas derived from coal or natural gas including areas such as catalysts for production of middle distillates.
- . Technology of exploration, assessment and recovery of oil and gas, with emphasis on resource assessment.
- . Improvements in coal combustion technology, particularly having regard to the characteristics of Australian coals and local conditions.
- . Improved coal productivity, particularly by reducing operational problems at increased depth and enhancing seam recovery, and by increasing efficiency in beneficiation plant.

### Medium Priority

- . Production of liquid fuels from oil shale and from coal by hydrogenation or pyrolysis, including the characterisation of Australian feedstocks, process evaluation and catalyst studies.



- . Energy conservation related to non-liquid fuels, particularly in industry, and in buildings.
- . Coal gasification.
- . Active and passive solar energy and wind, with emphasis on achieving cost-effectiveness in remote applications.
- . Coal carbonisation, largely evaluation of coals to complement industry-funded work.
- . Improvement in techniques for the exploration and assessment of coal and oil shale resources, with particular regard to reducing costs.
- . Methanol, with particular regard to end use and distribution problems.
- . Ethanol, with emphasis on processes showing strong promise for reducing production costs and on effluent treatment.
- . Energy storage, particularly for remote areas.
- . Nuclear waste management.

#### Low Priority

- . In-situ coal gasification.
- . Magneto-hydrodynamics.
- . Vegetable oils, with regard mainly to potential applications.
- . Production of methane from biomass feedstocks.
- . Production of liquid and gaseous fuels by pyrolysis of wastes.
- . Development of electric vehicles.
- . Nuclear fusion.
- . Use of hydrogen as a fuel.
- . Wave, tidal, ocean thermal and geothermal energy.

#### ACCOUNTANCY AND LEGAL STUDIES RELEASES SECOND EDITION OF NZ STUDY

Professor John Ryan has released the second edition of a survey of the financial reporting practices employed by the top 100 New Zealand holding companies in their annual accounts. The edition includes the 1979 year from the first edition, plus 1982 and 1983.

The format of the second edition has been reorganised to emphasise the accounting standards issued by the New Zealand Society of Accountants. Part I includes details of the survey companies, their statistical profile and general issues. The standards are included in Part II, with the identifying numbers of the standards being used as the chapter numbers, at once highlighting the standards and facilitating reference to them. Within each chapter, the standard and any relevant sections of the Companies Act are followed by the analysis and examples of presentation. Part III, dealing with other areas of practice, is organised similarly.

The main objective of the series is to analyse the accounting practices used by companies in their financial statements in relation to accounting standards and relevant sections of the Companies Act. International account-

ing standards have been referred to as appropriate. The heart of the study is the results of the analysis reported in the tables. Brief interpretative comments have been included throughout.

Professor Ryan said he hoped that the surveys will prove useful to students, the accountancy profession and the business community generally. "Researchers and students should find the bank of basic data on company accounting most useful; the examples of actual practice should provide guidance to controllers, financial managers, public accountants and seniors involved in the preparation of company financial statements. We have been encouraged by the success of the first edition", he said.

#### HEALTH OUTREACH — NEW APPOINTMENT

Leigh Farnell has been appointed to the School of Health Sciences with the stated objective of spending half his time in teaching and half in creating a health outreach programme.

The Community Outreach Programme will include:

- . health promotion
- . healthy lifestyle promotion and education
- . employee health promotion
- . employee stress and health
- . enhancing the quality of work life through employee health programmes
- . employee and executive stress management programmes.

Mr. Farnell intends to set up community courses in healthy lifestyle management, and stress and positive health including lifestyle, health and fitness evaluation and counselling. This will involve measuring blood pressure, body fat, heart and lung function, lifestyle habits and other variables to help determine the level of health and fitness.

To achieve his goals Mr. Farnell will be looking to

- . consult to companies on employee lifestyle, health, fitness, recreation and safety programmes.



- conduct in-house employee health and fitness evaluation and counselling for companies.
- advise on community fitness and recreation programs.

He hopes to get involved in a number of community groups in line with his interests in swimming, surfing, skiing, running, aerobics and theatre.

He also hopes to work in, with and through radio, television and print media to promote positive health. He is experienced in media, having had an exercise to music - health education segment on ABC radio and TVW7 in Perth last year.

Mr. Farnell is a graduate of Melbourne University, majoring in exercise physiology. He has recently completed a Masters Degree in Physical Education at the University of Western Australia.
