TWO CHAIRS FILLED

The Chancellor of the University, the Hon. Justice Hope CMG, has approved the appointment of two Professors in the Departments of Business Policy and Operations, and Psychology. Their biographical details are shown below. Both will take up their appointments early in 1986.

Professor and Chairperson of the Department of Business Policy and Operations — Mr J.F. Lowe.

Mr Lowe was born in Derby, England in 1945 and is married with four children. He was awarded a Bachelor of Arts degree in Economics from the University of Wales in 1967 and a Master of Arts degree in Economics and Business Administration from the University of Manchester in 1968.

Since 1969 Mr Lowe has been a lecturer at the University of Nottingham and the University of Bath and was appointed a Senior Lecturer in 1981. In 1984 he was an Australian Studies Visiting Fellow at the University of Queensland. During 1985 he has been seconded as a Research Fellow to the Committee of Vice-Chancellors and Principals for a study of University Science Parks and Companies.

Mr Lowe has an extensive publication record including nine books, has been active as a consultant to private

companies and public agencies (including the Queensland Department of Industrial Development) and is a Director of two private businesses.

Professor and Chairperson of the Department of Psychology — Dr W.J. Lovegrove.

Dr Lovegrove was born in 1945 and is married with three children. He was awarded a Bachelor of Arts degree in 1968, a First Class Honours degree in 1969 and his Doctorate of Philosophy in 1972, all from the University of Queensland.

Since 1973 Dr Lovegrove has been on the staff of the University of Tasmania as a Lecturer initially, promoted to Senior Lecturer in 1979 and to Reader in 1985. He is currently elected Head of the Psychology Department.

Dr Lovegrove has published extensively in prestigious journals and has received numerous research grants. Current research interests include specific reading disability or dyslexia, colour-spatial processing, monocular rivalry and perceptual alternations, temporal processes in spatial frequency channels and planned projects will consider the relationship between vision, phonological encoding and aspects of memory in specific reading disability.

LEAL APPOINTED DEPUTY VICE-CHANCELLOR

Professor Barry Leal, Professor of French and Chairperson of the Department of European Languages, has been appointed as Deputy Vice-Chancellor (Academic) at Macquarie University. The other Deputy Vice-Chancellor, Gareth Roberts, is in charge of Finance and Buildings.

Professor Leal has a M.A., B.A. and Dip.Ed from the University of Sydney, a Ph.D from the University of Queensland, a Certificat d'Etude Francaises from the University of Bordeaux and a Bachelor of Divinity from the University of Melbourne.

His distinguished academic career is as follows:

He has written two books on the French author Drieu La Rochelle and numerous articles.

He is well known for his active participation in local affairs having held the following posts:

 Member, Channel 0/28 committee: 1980- (formed to bring multicultural television to Wollongong);
 Foundation member, Wollongong Gallery Society.

Professor Leal was also a member of the N.S.W. Board of Senior School Studies and Chairman of the Australasian Universities Language and Literature Association.

Professor Leal's major contribution to the University of Wollongong has been:

1. the foundation of an active, happy and generally well-respected Department, and
2. in particular the introduction in 1977 of Italian at a time when support for the extension of modern languages in the University was not very strong. "Following the establishment of Italian it was gratifying to see the development of enthusiastic community support largely thanks to a judicious choice of Italian staff", said Professor Leal.

Professor Leal's daughter, Suzanne Leal, recently came first in the National competition "Concours La Perouse" run by the Alliance Francaise. Professor Leal says that Suzanne's French teacher, Caroline Kayser, can take all of the credit for this triumph.

JOHN TONG MOVES TO IBM

John Tong, the Senior Administrative Officer in charge of the Administration Data Processing Unit has resigned to take up a post at IBM, Sydney.

John began his career at the University of Wollongong in 1977 as an analyst/programmer.

A Life Member of the Friends of the University, John will be remembered by the wider community for his contribution to chess. He instigated the Friends/Commonwealth Bank High Schools Chess Competition, and contributed to it by service and cash donations. The competition brings about 150 school chess players to the campus each year from the South Coast, Macarthur and Southern Sydney schools.

LEADER IN SPACE EXPLORATION COMMENDS THE ILLAWARRA PLANET- ARIUM PROJECT AND THE TECHNOLOGY CENTRE

Professor Don Mathewson, Director of Mount Stromlo and Siding Spring Observatories and Professor of Astronomy at the Australian National University was in Wollongong last week to give a lecture at the University about Australia's first astronomical venture into space.

Detectors developed at Mt Stromlo Observatory will fly on a shuttle mission in 1987. The detectors are more sensitive than any before developed and will never be improved upon, since they are able to detect and record every photon that falls on them. In the shuttle mission they will be tested on two 10cm telescopes. Despite the tiny size of the telescopes, the immense power of the detectors will enable the experiment to look at regions of deep space where explosions have taken place many millions of times more powerful than any man-made explosion. The trial experiment will be accompanied by

an Australian astronaut — a civilian scientist to watch over and evaluate the performance of the equipment. Having passed its first space trials the detectors will then become the heart of a satellite experiment, code-named FUSE/LYMAN which will be flown in a joint venture with the European Space Organisation and NASA.

The entire venture, Professor Mathewson stressed, is purely astronomical and has no star-wars connections.

Professor also stressed the importance of development of space technology for the future of Australian Industry. "We are in the habit of importing our technology and just building copies. Australian university graduates are better in important ways than graduates from overseas and are able to contribute to development of unique Australian products. We have too negative a view of our own capabilities. I have great faith in the youth of this country. Initiatives in Wollongong, like the Planetarium and the Technology Centre, are important for getting Australia moving into the new age of high-technology science and industry.

The Planetarium will be a vital link, communicating the new results of high technology and the results of space exploration to the general public."

PRIORITY ONE – YOUNG AUSTRALIA

A pamphlet under the Priority One programme is available from the Editor. An extract is reproduced below;

Higher Education in 1986

Despite difficult budgetary circumstances, the Commonwealth Government will increase its funding of universities and colleges of advanced education by \$39.35 million in 1986 and by \$67.4 million in 1987.

This is an increase of 1.9 per cent in real terms for 1986, building on the 2.8 per cent increase in 1985 – the largest funding increase since the Commonwealth Tertiary Education Commission (CTEC) was established in 1977.

The continued expansion of the tertiary sector is in recognition of its importance in the Government's overall Strategy for Young People and in helping shape national economic recovery.

One of the major features of the expansion is to provide an extra 5500 student places in universities and colleges of advanced education by 1987 – in addition to the extra 15,000 places announced in 1984.

This increase reflects the Government's intention to encourage greater participation in the education system.

The Government has made a firm commitment to growth in the tertiary sector because of the vital role education has in serving the needs of a changing economy and in ensuring young Australians have adequate opportunities to achieve their full potential through education and training.

The Prime Minister's policy statement on the Commonwealth Government's Strategy for Young People reiterates the Government's commitment to growth in the education opportunities. This is one essential element of the Government's overall plan to enable young people to progress towards independence and a sense of personal worth, and to enable them to move toward self determination and economic self sufficiency.

Recurrent grants for higher education will increase by \$34.85 million in 1986 and include:

- * an extra \$23.1 million for recurrent costs, including those associated with pipeline growth in enrolments from increases in intakes in 1985 and earlier years and for extra superannuation costs;
- * a further \$11 million for an extra intake of between 1750 and 2250 students in 1986, building on the success of the Government's initiatives in providing resources for increases in intakes in 1984 and 1985.

The Government expects the funding allocations by CTEC to take account of the uneven levels of part-

icipation in particular States and regions, and expects extra new places to be allocated to Aboriginal students.

Equipment grants will increase by \$1 million and be directed to institutions where increased enrolments are anticipated, especially in the science/technology fields.

Capital grants will increase by \$3 million for new high priority projects to accommodate growth arising from previous intakes and the extra enrolments funded for 1986.

SCHOLARSHIPS AND TAXATION

Following several recent enquiries from postgraduate students and the Taxation Office concerning taxation of scholarships, it would seem that the taxation implications of scholarships are not well understood.

Section 23(z) of the Income Tax Assessment Act states, in part, that income derived by way of a scholarship is exempt from tax, but that exemption does not include "an amount received by the student from a person or authority upon condition that the student will (or will,

if required) render, or continue to render services to that person or authority; ... income derived under a Post Graduate award granted under the Student Assistance Act 1973;".

The effect of that section is that where a student is required to provide a service to the donor of the scholarship money, irrespective of whether the student made that arrangement or not, the student will be liable for tax on the scholarship amount he/she receives. Research grants are also usually assessable, as was held in the case of a doctor who received a grant to carry out special research at a university.

The CCH 1985 Australian Master Tax Guide gives several examples of decisions concerning scholarships and taxation.

The proceeds of a postgraduate research scholarship granted to a doctoral student by a university out of funds provided by the Asthma Foundation were held not to be exempt (FC of T v Hall). The scholarship was funded by the Foundation on the condition that the student would analyse, collate and prepare for publication the findings of a survey conducted on behalf of the Foundation. The work done by the student on this project was accepted by the university as part of his research programme for a PhD. The university passed on the payments from the Foundation to the student through its ordinary payroll procedures.

The Court held that the payments made under the scholarship were not received by way of "Scholarship, Bursary or other educational allowance" and even if so termed, the payments were made on condition that the student render services to the Foundation.

Conversely, the Commissioner has ruled that monies received from Radio Research Board Scholarships are exempt from tax under Section 23(z). Those scholarships are awarded to students to carry out postgraduate research leading to a doctoral degree. The students are not required to provide services to the Board and have a wide area of choice in their research topic.

The above should be borne in mind when academic units are negotiating scholarships with potential donors with respect to the nett amount of stipend that will be available to students.

Obituary

VALE MARION WALSH

Marion Lily Fletcher Walsh, passed away on Thursday, 26th September 1985 at the age of 70.

Marion was born in London on 16th September 1915 and became an infants school teacher in Hertford. In 1940 she married an Australian — David Walsh — who was visiting England when the second World War broke out. The newlyweds came by boat to Australia in 1941 after a hazardous journey across the war-stricken Atlantic Ocean and through the Panama Canal, dodging U-boats on the way.

In late 1941, Marion and David Walsh took up residence at the Mount Keira Scout Camp, where David was to remain as Warden for over 40 years until retirement.

After settling at the Scout Camp, Marion began a very active life of complete involvement which would have few parallels in the Wollongong community. She brought with her from England a deep love of music and history.

Marion after a few years resumed her career as an infants school teacher, and many residents of the Wollongong area will remember her as a truly gentle person whose efforts to guide and teach young children greatly exceeded the normal requirement of her duties.

Marion took a deep interest in the WEA when it was formed and served as a local tutor; a Councillor; elected President of the Wollongong WEA for over 10 years; was the Illawarra representative on the State Executive Council, and finally became the State President of the WEA.

She worked to have the present WEA offices established in Corrimal Street, Wollongong, and organised many of the live-in weekend WEA seminars at the Scout Camp. Marion not only helped in the organising, but worked hard in the background catering for these seminars.

Marion in her role of hostess at the Scout Camp came to meet many famous personalities whom she invited to autograph a large tablecloth, which she would embroider to become a permanent record of those who visited the camp.

Marion is especially remembered by the Friends of the University for her work on the Graduates Group, of which she was one of the founding members.

Marion had a life-long interest in brass rubbings at old churches and other historic locations. She was an authority on period costumes of past centuries, and also worked to draw attention to the need to document Australia's early history

and to encourage the preservation of suitable early buildings.

The Business and Professional Women's Association were proud to have Marion Walsh, and will remember her for her active involvement in many matters.

It was an essential part of her character that to be merely a member of any organisation was not enough to satisfy her desire to participate fully in community life, and to work for its betterment. She strived to have Australia Day elevated to its rightful position of dignity — to be celebrated on the day on which it falls and not to be just another long weekend.

Vandalism greatly concerned her, and she worked on submissions to Council to have a community youth worker appointed to try to counter this increasing social unpleasantness.

After retirement from teaching, Marion resumed her own studies and was awarded a Bachelor of Arts degree from the Wollongong University.

She was a staunch supporter of the A.B.C. Concert Committee, and fought to have the concerts retained in Wollongong when their inclusion on this circuit was threatened.

Gardens were a particular love, and those around the Warden's cottage at Mt. Keira were a tribute to her. Again, it was not just enough to have a pleasant garden — Marion decided to specialise in iris which thrived in the elevated Mt. Keira climate. In her own position, she became an authority on iris varieties and has held the post of President of the Iris Society.

Ever sensitive to the needs of others, Marion worked to have a fragrance garden planted in MacCabe Park to benefit those among us with restricted vision. Her efforts in this regard were recognised a few short weeks ago when on 31st August 1985 Marion was invited to unveil a memorial plaque at the opening of the fragrance gardens.

Marion was a member of many other committees, and her support will be long remembered in the field of conservation by the members of the Illawarra Natural History Society and the South Coast Conservation Society.

But despite this active community life, Marion Walsh will perhaps be best remembered for her role as a mother of six children, a grandmother and the loving wife of David. Her background of support to David allowed him to play an increased role in many other aspects of life in Wollongong.

Marion Walsh was one of Wollongong's most loved and respected residents.
