

PLANNING THE FUTURE

Senior members of the University met for two days at Ranelagh House, Robertson, recently to determine the University's future directions. The aims of the conference 'Planning the Future' were to develop clear strategies, particularly to the year 2000; and to identify the particular strengths on which the University should build to increase progressively its distinction.

The conference was attended by all Professors, Deans of Faculties, Heads of Academic Units and Senior Administrative staff. The conference addressed such issues as the image and reputation of the University, its academic profile, research and scholarship, methods of disseminating knowledge and marketing strategies. To assist the University with questions relating to student perceptions of the strengths of the University, marketing consultant, Mr Gidley McCullagh, participated in the conference.

The Vice-Chancellor Professor Ken McKinnon said,


UNIVERSITY CELEBRATES ITS 25TH BIRTHDAY ON APRIL 3

The University of Wollongong had its beginnings as a College of the University of New South Wales in 1962. We thus have our 25th anniversary this year. The occasion is to be marked with a celebration ceremony on April 3, a date chosen to coincide with the opening of the new administration building. More details will be announced in *Campus News* as planning proceeds.

A good deal has happened between 1962 and the present day. Then 280 students were enrolled in Science, Engineering and Metallurgy courses. In subsequent years the College resources and student intake increased to the point where the institution gained autonomy and became The University of Wollongong in January 1975.

In 1982 the University federated with the Wollongong Institute of Education which effectively extended the range of courses available from those offered at university level to include advanced education courses.

In more recent years the rapid increase in student enrolments has allowed the progressive development of courses which are designed to keep pace with advances in technology and thought. In 1987 the total number of students enrolled reached 8,000, which in terms of size places The University of Wollongong in the middle range of Australian universities.

"There is no reason why universities should be exempt from the planning disciplines imposed on everyone else by Australia's present position. Planning in The University of Wollongong is a continuously evolving exercise. The conference has been extremely valuable in sharpening existing planning as well as in providing a forum for exchange of information and identification of the key issues confronting universities." Professor McKinnon went on to say that the conference had been successful in identifying the directions The University of Wollongong should take and the strategies for their implementation. As a result it now has revised its mission statement and operational objectives. A revised planning document exploring detailed implications will be circulated within the wider University community for further discussion, modification over the next few months, and subsequently, implementation.

SPACLALS COME TO WOLLONGONG

The South Pacific Association for Commonwealth Literature and Language Studies (SPACLALS) is to have its home for the next three years in the Department of English at the University of Wollongong. The new Chairman is Mr William McGaw. Other members of the Committee are Ms Dorothy Jones (Secretary), Mr Michael Stone (Treasurer), Dr James Wieland and Mr Des Davis.

Mr McGaw was installed as chairman at the general meeting which concluded the Fourth SPACLALS Conference held at Massey University, Palmerston North, N.Z., from February 9-13. Elections at the end of 1986 had seen the Wollongong team elected unopposed. For the past six years SPACLALS has resided in the University of Canterbury, Christchurch, and before that in the University of Queensland.

SPACLALS is the regional organisation of ACLALS, the premier world organisation in the field of New Literatures in English. There are six other regional organisations which operate under its banner and with which SPACLALS liaises. As well as holding an International Conference for writers and academics every three years, SPACLALS publishes a biannual literary journal, SPAN, and a quarterly newsletter. It also seeks to promote the publication of indigenous literatures in English in the region by way of subsidy and entrepreneurship.

The unanimous choice of Wollongong as the new home of SPACLALS and the venue for its next major Conference in February 1990 stems from the reputation which members of the Department of English have established in New Literatures criticism in recent years. Dr Wieland has published extensively in the area for the past eight years and Ms Jones and Mr McGaw for the past five years. Each has consistently delivered papers at international conferences in the field, particularly in Europe, Canada, Singapore and Australia.

Wollongong's acceptance of SPACLALS coincides with the establishment of a New Literatures Research Centre in the Department of English. Dr Wieland, who is treasurer of the other major organisation in the field, the Association for the Study of Australian Literature (ASAL), will be its foundation director.

Annual membership of SPACLALS has been set at \$14 pa for the next three years. The committee is particularly hopeful, however, that existing and new members will take advantage of a triennial fee of \$40 as this will allow better planning of activities during SPACLALS' term in Wollongong.

ARTIST-IN-RESIDENCE

Jan Irvine has begun her period as artist-in-residence in the Textile Department of the School of Creative Arts. This project has been cofunded by The University of Wollongong and the Crafts Board of the Australia Council

and will go through Semester 1 and into the beginning of Semester 2.

Jan works as a fibre artist and exhibition designer. Her work as fibre artist includes her own work in fibre (employing techniques in dyeing and quilting) and large commissions, often to an artist brief.

During her residency, as well as completing some works of her own, Jan will be carrying out a commission for the Australian Bi-centennial Exhibition. This commission will be to construct a fabric wall 25 metres long which will serve as a backdrop for the Environment section of the exhibition. She will be designing this in consultation with the ABE curator and designers.

In carrying out the commission during her residency, Jan is offering students an opportunity to become aware of the requirements and procedures of large commissions and will draw some students into the project as assistants.

Her work as Exhibition Designer has involved her in a range of arts administrative roles involving associations with formal galleries, touring exhibition programs and the arts funding organisations both in South Australia and more recently New South Wales.

Jan will be working in the Textile Department Room 110 Building 25, on Tuesdays, Wednesdays and Thursdays. She will be guest lecturer in Visual Arts Theory on March 18.

OFFICIALS FROM SOUTH-EAST ASIA

Government officials from five of the six ASEAN nations have gathered in Wollongong this week for the beginning of an eight-week training program directed by the Centre for Technology and Social Change at The University of Wollongong.

The program was established under an agreement between Australia and the ASEAN nations. Its purpose is to train ASEAN officials in the formulation of strategies for the use of science and technology in development.

Professor Ron Johnston and Professor Stephen Hill, Directors of The University of Wollongong's Centre for Technology and Social Change, were selected by the Australian Government to direct the program.

The ASEAN officials will participate in a ten-day course of lectures and seminars surveying approaches to managing science and technology for development. The ASEAN

countries and Australia face many common problems in making their scientific organisations and their industries adapt to new requirements. Recent initiatives to boost the rate of innovation in Australia will be introduced to the participants by Dr Rod Badger from the Department of Science, and Mr Rick Gould from the Department of Industry, Technology and Commerce.

MANNING CLARK TO SPEAK ON VALUES IN EDUCATION

Professor Manning Clark will be the keynote speaker at a conference on the theme of 'Education Towards 2000: Common Values in a Diverse Society?'

To be held at Sydney University on March 20, the conference is organised by the NSW Institute for Educational Research, an independent body of educators committed to service and research in education.

The conference organiser, Dr Alan Watson, commented on the purpose of the conference.

'In recent decades much emphasis has been placed on individuality and on our multicultural character. Now, because of this diversity, we need to ask whether we have unifying purposes for public education. What should these unifying purposes be?

'In addition, difficult economic times place new pressures on education. Only with clear values can intelligent priorities be set and difficult choices made.'

Manning Clark has provocatively called the past ten or fifteen years a period of turbulent emptiness. At the conference he will seek to project future directions for society and education; the title he has chosen for his address is *Beyond Turbulent Emptiness*.

Also speaking will be Professor Eric Willmot, 1986 Boyer lecturer and prominent member of the Aboriginal community. Other speakers will include Mr Bob Winder, Director-General of Education in NSW and Dr Bill Andersen, philosopher of education at Sydney University.



STAFF DEVELOPMENT OPPORTUNITY

The University of New South Wales regularly holds a University Management Course for its general staff. This year one or two places on the course, being held from 5th to 8th April, have been offered to staff members from our University.

The course, which is residential, is designed to introduce participants to the basic elements of management — managing people, planning, controlling operations and problem-solving.

Participants will have the opportunity to exchange views, find out more about universities from their colleagues and assess their own training and development needs.

Nominations are sought from general staff members who:

- are managers or supervisors, or who are in a professional and other positions responsible for carrying out duties that involve leading and supervising others, or who are seeking to acquire such responsibility;
- would now like to take a broader management perspective of their duties and University administration;
- wish to commit themselves to the residential course.

Attendance at this course by the successful nominee will be supported by central University funds.

PART-TIME TEACHING PROCEDURES

The following procedures must be followed in order that part-time teachers are paid promptly.

Before any payment can be processed it is necessary that a 'Part-time Teaching Approval and Commitment Sheet' is submitted to Salaries where a serial number is allocated. The sheet is next forwarded to Budgets where funds are committed, the appropriate account number determined and an order number allocated.

Upon completion of the foregoing the authority then passes to the Deputy Vice-Chancellor for approval and back to the Salaries Section. At this point the yellow copy is returned to the originating department as an indication of approval as well as providing details of the commitment, together with the order and account number which must be included on all part-time teaching returns.

Part-time teaching returns not completed correctly will be returned to the appropriate department for amendment with the possible resultant delay in payment.

The cut off time for the receipt of part-time teaching returns at the Salaries Section is noon on the Monday preceding a normal pay day and may include claims for the fortnight concluding on the previous Friday. Timesheets received at Salaries after the cut off time will not be processed until the next pay day.

In order to avoid delays, confusion and misunderstandings these procedures should be brought to the attention

of those responsible for the employment of part-time teaching staff.

SUPERANNUATION INFORMATION SESSIONS

Information sessions on both the State Superannuation Fund (or 'old' fund) and the State Public Service Superannuation Fund (or 'new' fund) will be held on Thursday April 30.

The sessions allow staff to gain an understanding of how the particular fund works, what happens to your money, and what you are likely to get when you retire. Staff will be able to ask questions during the session and/or privately at the end of the session.

ARE YOU STUDYING?

Members of the general staff who are undertaking a course of study may be eligible for study time.

Full details of the study time scheme are nominated in a booklet, available from the Personnel Services Branch. There are a number of options under the scheme and staff are advised to read the booklet carefully to determine their best option.

Briefly, the study time scheme aims to provide assistance to staff members studying external (correspondence) or part-time courses approved by the University. Generally, the course must be relevant to the staff member's work or future work at the University. Time off work can be granted as: time each week up to a maximum of four hours to attend classes and/or undertake private study; accrual of days to use for study prior to the examinations up to a maximum of five days a year; time to attend compulsory residential schools (for external students). Leave to attend examinations is also available to staff granted study time.

RETIREMENT PREPARATION SEMINARS — STATE SUPERANNUATION BOARD

The State Superannuation Board has been conducting Retirement Preparation Seminars in Sydney and in some country locations since 1973.

The Seminar extends over two days and covers social and financial aspects of retirement, including sessions on Health, Investment, Taxation, Estate matters, Superannuation and the Roll-over option.

The Board has scheduled 70 Seminars during 1987 including 12 seminars in country centres.

Fund members who have been identified as being within one year of normal retirement age have been contacted in writing by the Board and invited to nominate to attend a seminar.

WHY EEO?

We are all aware that the University has an obligation under both Commonwealth and State Anti-Discrimination Legislation to implement Equal Employment Opportunity. Those of us fortunate enough to have been exposed to EEO in practice in Australia and overseas have noticed the varying degrees of acceptance accorded these programs. Acceptance ranges from lukewarm resignation to enthusiastic embracing of equity concepts.

The university's policy very simply states 'Equality of employment opportunity is a matter of basic social justice'. Given that the Australian concern for 'a fair go' for everyone is basic to our commitment to EEO principles, what other benefits can we expect to attain? Why do I, as your co-ordinator, so whole-heartedly support this program and believe that it can be a winning situation for all of us?

Here are a few of the benefits I have observed in organisations or institutions which promote equal employment opportunity:

- Improved employee relations with an accompanying reduction of stress in the working environment.
- Minimised employee complaints and a considerable reduction in costly litigation or industrial disputes.
- Reduction in absenteeism and turnover with an accompanying increase in productive and creativity, based on an improved staff commitment to the organisation.
- More effective use of personnel - better job fit when the right person is selected for the job.
- Employee career aspirations more likely to be met when there is an increased knowledge of the skills and potentials of employees.
- Good reputation in the community widens the market for products or services.

There are probably many more benefits to be found. These are just some that I have observed. I would be interested in hearing from anyone who can add to this list.

However, one thing that we need to underline - EEO cannot be the sole responsibility of one or two individuals on campus. Like anything else that is worth while, it takes a commitment and willingness to work at it from all of us. However, an effective EEO program is *not* adversarial - it is a co-operative system, and there are no ultimate losers - only winners.

MUSIC FOR HURDY-GURDY

Stevie Wishart, Britain's leading exponent of the medieval fiddle and the hurdy-gurdy, will visit the School of Creative Arts on Wednesday March 11 to give a lecture on medieval and traditional music for these instruments. Once the stock-in-trade of the medieval minstrel or *jongleur*, the 'fidel' and the hurdy-gurdy, or *sinfonye*, have not survived. However they are frequently shown in paintings and sculptures of the period and it is from this evidence that they have been reconstructed. Fortunately, there is a wealth of repertoire for these instruments in manuscripts scattered throughout England and Europe; drawing on these sources, Ms Wishart will demonstrate the unique and fascinating sonorities of the popular music of the time.

Stevie Wishart is currently undertaking doctoral research at New College, Oxford, into the performance techniques of medieval instruments. She has broadcast for the BBC and the ABC, and is currently touring Australia giving solo performances as well as appearing with Sydney medievalist, Winsome Evans (Renaissance Players). She will return to Wollongong on April 1 to give a performance with singer Mara Kiek and actor Peter O'Shaughnessy of Chaucer's *Troilus and Cresside*.

The lecture, which is open to all members of the University, is to be held in the Music Auditorium (Building 24) at 11.30 am on Wednesday March 11.
