Derek Boothman

Giorgio Baratta (†)

was a philosopher who taught at the Università di Urbino, a tireless organizer on many fronts, responsible for many of the Gramscian links between Italy and Latin America, and President of the *International Gramsci Society- Italia*.

Luka Bogdanić

is a Yugoslav Croatian by birth who studied philosophy in Italy and now teaches at Zagreb University, as well as collaborating in research in Italy. Apart from Gramsci, he has concentrated in particular on the national question in the western Balkans.

Derek Boothman

taught at the Department of Interpretation and Translation of the Università di Bologna, has translated anthologies of Gramsci in English and now edits the *International Gramsci Journal*.

Riccardo Ciavolella

is an anthropologist and Director of the *Laboratoire d'Anthropologie Politique (LAP)* of the École des Hautes Études en Sciences Sociales, Paris. Linked to his sub-Saharan African studies are the questions of ethnological research in marginalized social strata.

Rita Ciotta Neves

is an author, biographer and former university teacher of literature; she was born in Italy but has spent most of her adult life in Portugal.

Martín Cortés

teaches at the Universidad de Buenos Aires. Apart from Gramsci, he has written on José Aricó, a founding-father of Gramscian thought in Argentina and in Latin America, while other books of his have been published in English by Brill.

Marcos Del Roio

teaches at the Marília campus of the Universidade Estadual Paulista in Brazil. He is the author of numerous publications on Gramsci in particular, some available in English translation in the Brill series.

Romain Descendre

is an Italianist teaching at the École Normale Supérieure, Lyon, who among other things deals with the History of Political Thought, going back to Giovanni Botero in early modern times. One of his special Gramscian topics is the that of translatability.

Paolo Desogus

is an Italian working in the “Unité de formation et de recherché” (UFR) of Italian Studies and teaching contemporary Italian literature at the Sorbonne Université (Paris). Apart from Gramsci, particular interests of his include the work of Pasolini.

Lea Durante

has a particular interest in Gramsci, literature and feminist work; she teaches at the University of Bari, is Director of the *Centro Interuniversitario di Ricerca per gli Studi Gramsciani* and vice-president of the *International Gramsci Society-Italia*

Gianni Fresu

is President of the *International Gramsci Society Brasil*, currently on leave from the *Universidade Federal de Uberlândia (Brazil)* to carry out research at the University of Cagliari. He has published extensively on Gramsci in Italian and Portuguese.

Diana Fuentes

teaches at the Universidad Autónoma Metropolitana (Xochimilco, Mexico City) and has recently been elected President of the *International Gramsci Society México*.

Anxo Garrido Fernández

teaches at the Universidad Complutense de Madrid, is active as author and translator of works on Gramsci, and is President of the *Asociación Española de Estudios Gramscianos*.

Sebastián Gómez

is a researcher at the National Council of Scientific and Technical Research (Argentina) and teaches at the Faculty of Philosophy and Literature of the University of Buenos Aires (UBA)

Marcus E. Green

teaches at the Pasadena City College (California), is Secretary of the International Gramsci Society and is continuing the work of Joseph Buttigieg on the integral translation into English of the *Quaderni del carcere*.

Miguel Angel Herrera Zgaib

teaches Political Science at the Bogotá campus of the Universidad Nacional de Colombia and has written widely on contemporary America history and on Gramsci.

Guido Liguori

teaches at the Università della Calabria, is the author of numerous works on Gramsci, often translated into other languages, and is President of the *International Gramsci Society*.

Patrizia Manduchi

is an Arabist working at the Università di Cagliari, one of the moving spirits behind the *GramsciLab -University of Cagliari* and Cagliari co-organizer of the Conference. For the *Fondazione Gramsci* (Roma) she co-edited the volume *Gramsci nel mondo arabo*.

Alessandra Marchi

is a member of the *GramsciLa-University of Cagliari*, with special interest in Gramsci and the Mediterranean Arab countries and Cagliari co-organizer of the Conference; For the *Fondazione Gramsci* (Roma) she co-edited the volume *Gramsci nel mondo arabo*.

Massimo Modonesi

teaches at the Universidad Nacional Autónoma de México, and has also held courses abroad. He is among the most widely-read Latin American Gramscian authors, in Spanish and in translation; recent work includes the formation of the political subject and the question of antagonism and political action.

Isabel Monal

is a philosopher and Emerita Professor of the Universidad de La Habana; after studies in pedagogy in the United States, she returned to Cuba and took part in the movement in the cities in support of the guerrilla movement headed by Fidel Castro. She is the long-time editor of the international review *Marx Ahora* published in La Habana.

Mauro Pala

teaches in the field of contemporary literature at the Università di Cagliari and is part of the *GramsciLab-University of Cagliari*. As well as Gramsci he has special interests in the work of Edward Saïd, and of Gayatri Spivak as well as in post-colonialism.

Sabrina Perra

is the Director of the *Istituto Gramsci della Sardegna* and Cagliari co-organizer of the conference whose Proceedings we are here publishing.

Ingo Pohn-Lauggas

is an Italianist, teaching at the Universität Wien and head of the Cultural Studies office there. He is author of works on Gramsci and co-editor of the special number (Vol 3, no. 4) of the *International Gramsci Journal* ‘Gramsci und Benjamin – Passagen’.

Panagiotis Sotiris

has taught in various universities and is currently an independent scholar; he has worked both on Gramsci (e.g. what the ‘Modern Prince’ means in today’s world) and Louis Althusser (including the hitherto unpublished manuscripts).

Natalia Terekhova

belongs to the *Association for the Study of Gramsci’s Heritage (OING)* in the Russian Federation and is a member of the World History Institute (IVI) of the Russian Academy of Sciences (RAN).

Fawwaz Traboulsi

is a long-time militant of the Lebanese left, translator of Gramsci and others – including Edward Saïd - into Arabic, and author of the authoritative *History of Modern Lebanon*; he has taught in various universities in Lebanon and abroad.

Yue Zhou Lin (Joe Lin)

is currently teaching at the University of Bristol (England). His publications include the areas of Gramsci in China post-1978, China’s global role, the integral State, the roles of Chinese intellectuals and development policies.

Fernando Zamorano

is an author and translator of works on Gramsci and others, including Antonio Labriola, and is a founder member of the *Associació d’Estudis Gramscians de Catalunya*.
